- Online application: calstate.edu/apply
- Transcripts
- Resume
- Personal statement
- GMAT or GRE scores (several waivers available, including for SJSU graduates, any CSU Accounting Major (or equivalent) and those who have passed the CPA or Enrolled Agent exam)
- WES evaluation and TOEFL or IELTS (required for international coursework)

Fall admission

- Domestic: October 1 - May 1
- International: October 1 - April 1

Spring admission

*1-2 years of tax experience required or have taken BUS 223A (Tax Research).

Domestic or International: August 1 - November 1
